2018/011. PUBLIC DISCUSSION OF ITEMS ON AGENDA

Residents raised concerns that the recent highways work has reduced the width of the pedestrian walking area at the northern end of the village. 2018/012. APOLOGIES / DECLARATIONS OF INTEREST / GRANT OF DISPENSATIONS – Apologies were received and accepted from Cllr Jim Cooper, Cllr Angela Bullock, County Cllr Rebecca Knox and District Cllr Alford.

2018/013. REPORTS FROM DISTRICT COUNCILLORS, COUNTY COUNCILLORS AND LOCAL POLICE OFFICER: County Councillor

Clerk read out report from Cllr Knox as follows:

A report for the meeting of the Parish Council – Rebecca Knox

"The Secretary of State has given Dorset the go ahead to form two unitary councils, which for us will mean residents will be looking to what will be called the Dorset Council. At the moment a parliamentary is being prepared to be laid in the Houses of Parliament which will create the new legal entity. Though secondary legislation and therefore deemed to be a process which is more process in theory it could be subject to some controversial discussion, but it is unlikely to be stopped entirely. The new organisation of Dorset Council will come into force on 1 April 2019, and in the meantime, a Shadow Authority will be created in June to ensure the transition from six councils to one takes place.

I have a considerable amount of detail about all of the above and there are some subject areas where is it is going to be really important to work with parish and town councils on to see what they view about certain aspects of service delivery – this could be a really good opportunity for closer working and to get more involvement with others in community, if that is what is appropriate.

I am going to be arranging a meeting in this area probably now for April so will keep you posted on dates – there is too much to potentially explore and it would be good to meet with others in the division.

Dorset County Council has voted to increase council tax to the limits which were set by central government. Part of the 5.99% will be used and ring fenced for social care (3%). This is a welcome amount however with the living wage to implement, most will be taken up to cover that cost in social care. There are some really exciting opportunities which Dorset is pursuing to increase the access and service to residents who need care particularly

for those remaining in their own homes, but we are also working with others to hopefully invest in homes suited to those who need more help. We are also investing considerably in social workers, for all ages, and foster carers."

District Councillors

District Cllr Barrowcliffe reported that previously land searches by the district council planning authority had been slow in being completed, however the time scales have been significantly reduced.

Cllr Barrowcliffe reported that the new unitary authority needs to set budget for the whole area, and it is hoped that the authority will save sufficient money in first year to cover the cost of setting up new authority. The Strategy committee has agreed to set up a local authority trading company to look at housing building initiatives, to hopefully address the shortage of new housing in the area.

Police.

Clerk read out the following report from PCSO Alex Bishop

Crime wise, in the early hours of 11th February, a commercial premises in Mosterton was broken into. A van with a tool chest were stolen, but fortunately the vehicle had a tracking device on board and was located.

Between 1st and 3rd March, unknown offenders broke into a vehicle left abandoned between Mosterton and Misterton, during the snow fall. A golfing Powacaddy was stolen. A trailer has been stolen from a field in Mosterton. This occurred between the 9th and 10th of March. Sometime recently, unknown offenders have stolen a quantity of fuel from Mosterton School. It is unknown when exactly this has occurred. - a) The statistics show a higher % of vehicles speeding through Mosterton compared with most sites.
- b) Our latest session at Mosterton Cross on Saturday morning identified 39 speeding vehicles out of a total of 373. Worryingly, 20 of the 39 were travelling at 40 mph or more. We estimate that 35-40% of those speeding were travelling through the village from the Crewkerne direction. A previous session at The Paddocks produced similarly high % of vehicles travelling at 40mph or more.
- c) There are several gremlins in the system at present with one of them erroneously indicating that no further action (NFA) was taken following one of our sessions at the Pumping Station (DBB017).
- d) The Mosterton statistics include a session by the police at Bandera Cottage (DBB015) where they only caught two speeding cars. One of our team David Ingram lives very close to Bandera Cottage and watched the police team in action. He is adamant that a considerable number of cars were speeding and that the police figures are not reliable.
